Textual Information(1)	It is respectfully submitted that the total issued and listed capital of the Company is 60,97,700. However, due to a clerical oversight, after the forfeiture of 19,52,400 shares, the Company inadvertently began reflecting the listed capital as 41,45,300, instead of continuing to show the correct listed capital. We would like to clarify that the forfeiture of shares does not impact the listed capital, and the correct listed capital continues to remain at 60,97,700. The discrepancy occurred purely due to a clerical error, which is now being rectified accordingly. We sincerely regret the oversight and request that the necessary correction be taken on record
